## CONFERENCE REGISTRATION POLICIES

Before registering for GCCA's Conference, it is important to understand our registration cancellation policy, which is detailed below. Upon registering for the conference, you will be considered to have accepted our terms and conditions as outlined below.

### Terms & Conditions for the 2022 GCCA Fall Conference September 11-14, 2022

#### CANCELLATIONS & REFUNDS

Cancellations will only be considered when received in writing. You may receive a refund for your conference registration (less a \$75 processing fee) for written cancellations received by GCCA ten business days before the start of the conference. Written notices of cancellation received within ten business days before the start of the conference will be assessed a \$150 processing fee.

Refunds may be granted if an attendee is unable to attend the conference due to a family death, illness, or other emergency circumstance. In such an instance, GCCA must be contacted by letter or email. If initial notification is by phone, it must be followed up in writing within 48 hours. Refunds will still be subject to a 15% processing fee.

#### REPLACEMENT/TRANSFER:

If you are unable to attend for any reason, you may be permitted to transfer your registration to another GCCA member within your court/agency without penalty. Submit your confirmation letter with a cover letter stating your request along with a completed registration form from the person replacing you.
